## Student ORCA and Transit Voucher Cardholders Rules of Use

As a Bellevue College (BC) Student ORCA or transit voucher cardholder, I agree to the following:

1. I am a qualified BC Student. For purposes of this program, a qualified BC Student is registered in 5 or more credits during the current quarter.
2. I will only use my ORCA card or voucher for my own transportation. **I will not transfer my ORCA card or voucher to any other person.** I understand that I may be blocked from participation in future benefits from the college if I misuse my card.
3. I will **register my ORCA card online** at [www.orcacard.com](http://www.orcacard.com).
4. I will keep my ORCA card secure and in good condition. I will immediately report a **registered lost, stolen, or damaged ORCA card to the King County Metro number on back of card and request a replacement.** If a registered card is reported lost or stolen Metro will block the card for further use on transportation services. The card is non-refundable. An ORCA card may be replaced only once a year for a cost equal to Metro's current replacement fee. Metro will replace a defective ORCA card free of charge. **Non-registered ORCA cards and transit vouchers will not be replaced. The card is non-refundable.**
5. I understand that the ORCA card and voucher is valid for the following services:
  - A. The card is preloaded with **ONLY \$120.00 or \$240.00 of transit fares** on regularly scheduled transportation service on Everett Transit, Community Transit, Kitsap Transit, Metro Transit, Pierce Transit, and Sound Transit.
    - a. \$120 transit value: cost is \$60 for students with 5 or more credits or under 19 years old
    - b. \$240 transit value: cost is \$120 for students with 10 or more credits.
  - B. **Students are responsible for registering their ORCA cards online** ([www.orcacard.com](http://www.orcacard.com)) and are able to add additional funds to their registered cards online. Vouchers expire after use.
  - C. Only one card per student per quarter.
6. I understand the ORCA system will record data each time I use my ORCA card. Data will include the date, time and location of the card when it is presented. I understand this data is owned by the ORCA Agencies.
7. I understand that the **ORCA card must be "tapped" on a card reader within 30 days of purchase** to active and to show proof of a valid fare. I will be subject to a fine if the ORCA card is not "tapped" and I understand I will be personally responsible for the fines that may be imposed.

I acknowledge the receipt of my non-refundable ORCA card, and understand and agree to the terms stated above for using the ORCA card.
