### **Course Catalog Description**

*Examine the roles that race, ethnicity, class, gender, sexuality, nationality, ability, and religion play in your life and in larger U.S. society. Using multiple means of analysis (scholarship, literature, and media), we will investigate how systems of power and inequality intersect and shape American society in both the past and present. Satisfies either Social Science or Humanities credit.*

### **Course Content**

While every attempt will be made to keep things PG-13, please know that there will be times where R-rated content (language, images, etc.) is necessary to examine course topics within an academic context. Students will not be penalized for excusing themselves from content they find objectionable or difficult to watch, see, discuss or listen to. ### **Learning Outcomes**

- Analyze how systems of oppression intersect with one another to create inequality and marginalization.
- Examine social issues from the perspective of marginalized groups and identify ways to work toward a more socially just and inclusive society.

## **Public Safety and Emergencies**

Among other things, Public Safety serves as our Parking Permits, Lost and Found, and Emergency Notification center. If you work late and are uneasy about going to your car, Public Safety will escort you to your vehicle. To coordinate this, please phone ahead and let Public Safety know when and where you will need an escort.
